## Foreword:

The ninth month of this year has passed, while the Israeli colonists are still perpetrating the worst forms of organized terrorism against the Palestinian people and their property. The occupational terrorism practices against Palestinians has clearly escalated to dangerous levels, threatening the worst, as long as the Palestinian people remained without international protection, and without a real deterrent to stop this colonial terrorism. Thus, the Palestinian people, including their children, elderly, women and youth, will remain subject to the Israeli direct killing, and their property will remain subject to confiscation in daylight.

Our monthly report presents a set of classified data and indicators that the Documentation and Publishing Department in the Colonization & Wall Resistance Commission were able to monitor and document in order to provide further evidence on the Israeli terrorism directed against the Palestinian existence.

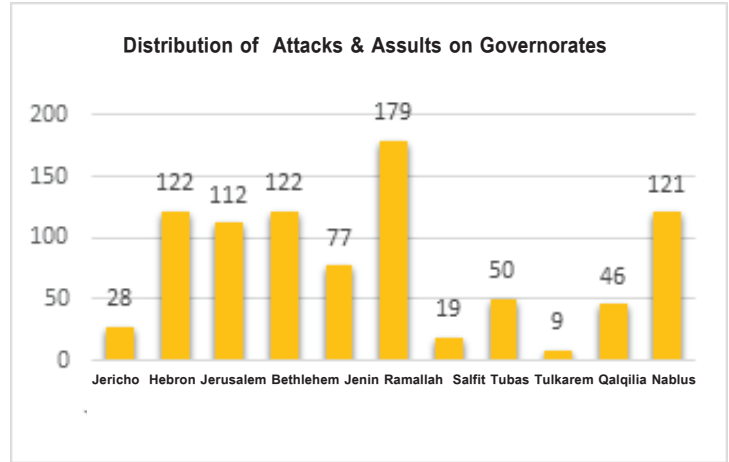

## Attacks on Palestinian Citizens & Their Properties:

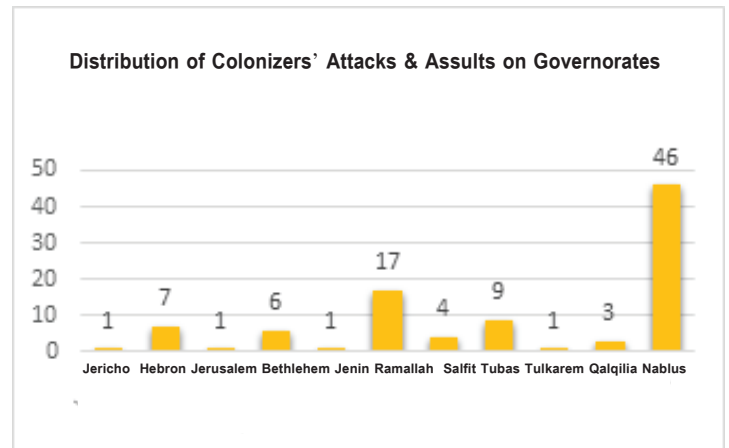
During the reporting period, September 2022, the Colonization & Wall Resistance Commission (CWRC) monitored 885 violations attacks. These colonial attacks affected individuals, property, lands and natural resources, and were concentrated in the governorates of Ramallah, Bethlehem, Hebron and Nablus.

During the aforementioned period, 18 Palestinian martyrs were recorded in the governorates of Jenin, Ramallah, Nablus, Bethlehem, Hebron and Tubas . These attacks took variant forms, as the colonizers perpetrated 96 attacks, while the number of attacks on property and land reached 190, including 37 demolitions, 58 cases of vandalism and destruction of property belonging to Palestinian citizens, as well as there were 24 cases of property confiscation, most of these properties are classified as agricultural properties, including barracks, tents and tractors.



### ● Colonizers' Attacks:

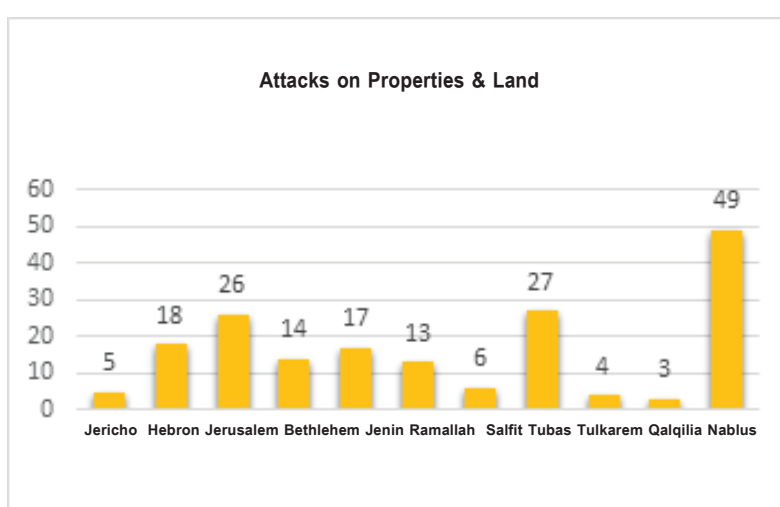
According to what was monitored and documented by the Colonization and Wall Resistance Commission (CWRC) during the reporting period, the colonizers carried out 96 organized crimes against Palestinian citizens and their property. The most prominent of these attacks is the attack that was carried out at the end of September on the village of Madma in the Nablus governorate. This attack caused the injury of eight civilians with bruises and fractures, while more than 50 citizens were injured by tear-gas inhalation.



The colonizers' attacks perpetrated during September 2022 were concentrated in Nablus governorate; as it witnessed 46 violent attacks, while 17 attacks were recorded in Ramallah, 9 attacks in Tubas, and 7 attacks in Hebron. These cities are surrounded by colonies that are considered the most extreme and fierce, and are home to the terrorist groups called "hilltop youth" and "price tag".

● **Assault on property & land:**

During the month of September, the Colonization & Wall Resistance Commission (CWRC) has documented 190 cases of attacks against Palestinian lands and properties. These attacks included the bulldozing of about 213 dunums, the demolition of 37 citizens' properties and issuing 50 demolition notifications. The most of these attacks were concentrated in Nablus governorate which witnessed 49 attacks; meanwhile, there were 27 attacks in Tubas, and 25 attacks in Jerusalem.

### ● Assault on Trees:

During the reporting period, the Colonization & Wall Resistance Commission (CWRC) has documented that 335 trees were uprooted by the Israeli colonial militias, including 225 olive trees. Most of these assaults were concentrated in Hebron governorate which witnessed the uprooting of 200 trees; meanwhile there were 80 trees uprooted in Salfit governorate and 45 trees in Nablus governorate.

### ● Demolitions:

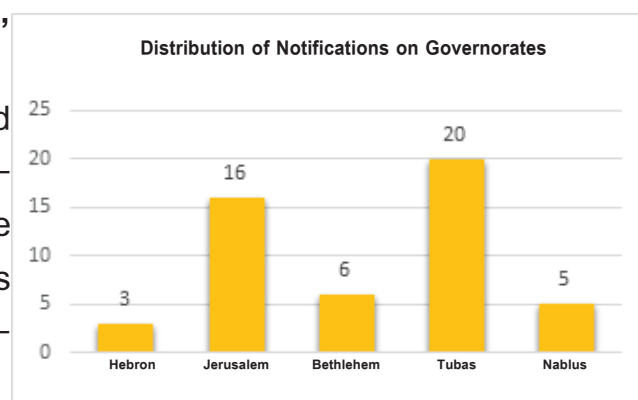
The number of demolitions carried out by the Israeli occupation forces during September 2022 reached 37 demolitions of houses, and 45 demolitions of commercial facilities and sources of livelihood, where they were concentrated in Salfit Governorate with 11 demolitions, Jerusalem with 8 demolitions, and Bethlehem with 5 operations that caused the demolition of 8 facilities.

**● Notifications (demolition, construction halt, eviction) in the West Bank**

In September 2022, the Israeli authorities issued 50 notification, distributed between 29 of demolition, 6 of construction halts, or 15 of eviction on the pretext of non-licensing. Most of these notifications are concentrated in Tubas governorates (20 notifications) and Jerusalem (16 notifications).



These notifications issued by the Israeli occupation authorities in the West Bank are considered one of the tools in besieging the Palestinians in Area C and preventing them from development and urban expansion in light of the occupation’s control over planning in those areas, denying the Palestinians from their right to prepare structural plans and disapproving them if they were submitted to the Israelis in order to exploit Area C, which represents 61% of the West Bank area, and to keep it for the expansion of colonies and as a strategic reserve for them in the future.

## Second, Israeli occupation measures for the purposes of colonial expansion

**first :** The approved and proposed (deposited) colonial expansion plans in the West Bank for the month of September 2022.

### ● Certified plans

The occupation authorities have approved (2) a new colonial plan, with the aim of expanding an existing colonies (according to the Israeli occupation claim), targeting (9,682) dunums of Palestinian citizens' lands, seeking to build (250) new colonial units.

**Second:** Building bids in the West Bank:

Last September, 6 bids were issued to build new colonial units in a group of colonies in the West Bank, the most prominent of which was the bid to build 434 new colonial units in the Suleiman pools area, as well as the bid that targeted citizens' lands in the village of Sur Baher in Jerusalem governorate.

1. Bidding No. 184/2022 for the construction of 5 units in Shaarei Ephraim colony.
2. Bidding No. 294/2018 for the construction of 20 units in the Karnei Shomron colony (Ginat Shomron).

3. Bidding No. 320/2021 for the construction of a hotel in the Dead Sea.
4. A new Bidding bid No. 2201/362 for the construction of 60 units in Elkana colony.
5. Bidding No. 2021/145 for the construction of 1,324 units and commercial and professional areas on an area of 80 dunums, within the framework of the evacuation and construction plan, and the construction demolished in the middle of the Gilo neighborhood built on lands Palestinians in Beit Jala.
6. Bidding No. 432/2021 for the construction of 83 units on the lands of Sur Baher and Beit Safafa in the new colony of Givat Hamatos.
7. Bidding No. 145/121 was issued for the construction of 434 units in the Solomon Pools area located in Bethlehem lands and previously annexed by Israel.
