Foreword:

It has become evident that the occupying force's plans to displace the Palestinians and to create a coercive environment by arming the colonizers, granting them immunity and training, as well as the official actions of the occupying state such as raiding cities and villages, carrying out executions, systematically destroying of the infrastructure, and imposing collective punishment on the Palestinians, have crossed many boundaries. What is noteworthy is that without the international silence and the flawed double standards, the Israeli occupation would not have been able to continue committing these horrific crimes in full view of the world, which appears content with remaining silent.

It is evident that there are coordinated plans between the Israeli occupying army and the colonizers to attack Palestinian farmers during the olive harvest season. In previous seasons, there have been dangerous attacks under the army's protection to prevent citizens from accessing their lands. This requires our people to organize large support and protection campaigns to thwart to these plans.



First: Violations of the Israeli Occupation State & Colonizers in the Occupied Palestinian Territories during September 2024:

During the reporting period, September 2024, the Colonization & Wall Resistance Commission (CWRC) monitored 1344 attacks. These attacks were carried out by the various bodies of the occupying state, including its colonial militia, against Palestinian citizens and their properties.

These attacks included physical injuries, whether by live bullets or gas, as well as incursions, sabotage, theft, and confiscation of property,




bulldozing lands, and uprooting trees.

However, the majority of these attacks occurred in the governorate of Hebron which witnessed 335 attacks. This was followed by Ramallah Governorate (179 attacks). Meanwhile, 154 attacks were monitored in Jerusalem governorate, and 143 attacks in the governorate of Nablus. There were also numerous attacks in the other West Bank governorates.

These governorates experienced intensive attacks, amounting to 60% of the total attacks. These included 360 attacks on property and religious sites, 74 attacks on lands and natural resources, and 910 attacks on citizens.

Attacks perpetrated by Israeli Occupation State & Colonizers against Palestinian citizens, their properties and holy places.

Attacks on citizens:



citizens. Most of these attacks were concentrated in Hebron Governorate which witnessed 185 attacks, followed by Jerusalem Governorate which witnessed 130 attacks. Meanwhile, 121 attacks were recorded in Ramallah governorate. These attacks included shooting, arrest campaigns, shutting down checkpoints and imposing traffic restrictions on citizens.



Attacks on Lands & Natural Resources:

During September 2024, the Colonization & Wall Resistance Commission (CWRC) has documented 74 attacks on the Palestinian lands and natural resources. These attacks were concentrated in Ramallah Governorate which witnessed 20 attacks, followed by Nablus Governorate (18 attacks). Meanwhile, 11 attacks were recorded in Hebron governorate.

These attacks affected hundreds of dunums of citizens' lands. During The reporting period, September 2024, there were four attempts by colonizers to establish colonial outposts on citizens' lands.



Additionally, the occupation authorities and colonizers carried out 19 bulldozing lands' operations. These operations were concentrated in the Nablus Governorate, where 7 bulldozing lands' operations took place, followed by the Hebron and Ramallah Governorates, with 3 bulldozing lands' operations for each¹.

Attacks on Trees:

During the reporting period, September 2024, the Colonization & Wall Resistance Commission (CWRC) documented 47 attacks that targeted olive trees and caused the uprooting, poisoning and burning of 699 trees among which there were 694 olive trees. These attacks were concentrated in Ramallah governorate which witnessed 16


attacks and Nablus governorate which witnessed 9 attacks. Meanwhile, 7 attacks were recorded in Hebron govrornorate.

Attacks on Palestinians' Properties:

In September 2024, the Israeli occupation forces and colonial militias carried out 360 attacks on Palestinian properties. They launched aggressive campaigns to confiscate,



steal, and vandalize citizens' possessions. The targeted properties included agricultural tractors, vehicles, bulldozers, camera recordings, money, sheep, bulldozers, trucks, mobile phones, blacksmith tools, printing press tools, fertilizers, agricultural equipment, seedlings, quarry equipment, water tanks, and more.

As a result of these campaigns, about 225 properties were confiscated, sabotaged, or stolen. Specifically, Israeli forces confiscated 8 vehicles, 4 sets of camera recordings, 3 agricultural tractors, 4 bulldozers and trucks, a mobile phone, blacksmith and printing press equipment, fertilizers, as well as they were involved in 4 cases of stealing mobile phones and money during inspections. Meanwhile, the colonizers were involved in the theft of: 307 sheep, 8 cases of agricultural equipment, 3 cases of agricultural seedling, 2 vehicle thefts, money, quarry equipment, and a water tank.


Colonizers' Attacks:

According to what was monitored and documented by the Colonization and Wall Resistance Commission (CWRC) during the reporting period, September 2024, the colonizers carried out 234 organized attacks.

These attacks varied between the occupation army's protection of the colonists in their storming of Palestinian cities and communities, breaking into Palestinian villages, confiscating citizens' property, drawing racist slogans on the walls, and bulldozing lands, as what happened in the villages of Um Safa, Deir Nitham, Majdal Bani Fadel, Surra, Qaryut, Einabous, al Nazla al Sharqiya, As Sawiya and Qarawa Bani Hassan. Furthermore, 33 vehicles were badly attacked, either by damaging or vandalism. Including the affected vehicles, there were 21 smashed and vandalized vehicles, 9 vehicles were set on fire and3 vehicles were exposed to gunfire in addition to throwing stones at the passing vehicles as well as the racist graffiti that were drawn on these vehicles.


The most prominent of these colonial attacks was storming the holy places; among which was the squares of Al-Aqsa Mosque in the occupied city of Jerusalem. During the reporting period, September 2024, 4432 Israeli colonizers, protected by the occupation army, carried out 20 raids into Al-Aqsa Mosque Squares. Besides, 3445

colonizers carried out provocative tours under what is called "tourism to the squares of Al-Aqsa Mosque". Notably worth, most of these attacks were concentrated in Hebron Governorate which witnessed 85 attacks, followed by Ramallah Governorate where 53



attacks were recorded. Meanwhile, 41 attacks were documented in Nablus Governorate.

A comparison between the number of colonizers' attacks in the West Bank governorates over the past three months:



Examples on the Colonizers' Attacks perpetrated in September 2024:

➤ On September 2, 2024: Settlers attacked the citizen Fouad Ghazi Bani Jame' from the village of Aqraba, southeast of Nablus. Bani Jame's brother said that dozens of settlers attacked his brother's home and severely beat him, causing bruises on his body, and stole about 250 of his sheep.



➤ On September 6, 2024: About three colonizers forcibly took over an abandoned house and turned it into a new colonial outpost in "Ras Ein al-Auja" Bedouin community, north of Jericho. They brought in a flock of sheep, established a pen, and installed a water tank nearby.

- ➤ On September 6, 2024: Armed Israeli colonists attacked Palestinian villagers of Khirbet Zanuta, south of the occupied West Bank city of Hebron while others set up a tent at the archaeological site of Bir Ma 'in in Masafer Yatta, south of Hebron. The colonists assaulted several villagers while the latter were at a water well belonging to "al Batat" family in the village of Zanuta, near the town of Al Dhahiriya, south of Hebron. They beat the citizens them and prevented them from using the well. The villagers attempted to fend off the colonists' attack, but a number of them ended up sustaining bruises and cuts. Meanwhile, a large number of colonists stormed the site of Ma 'in Well (Bir Ma 'in) in Masafer Yatta, prevented Palestinians from approaching it, set up a tent at the site and performed Talmudic rituals there.
- ➤ On September 8, 2024: A group of colonizers abducted and assaulted the elderly man, Baji Salem Abu Sharkh (68 years old), while he was grazing sheep, from Dhahiriya town, south Hebron city, south of the occupied West Bank.
 - The residents then began searching for him immediately after he was abducted by the colonizers. Then, the Israeli army reached before the colonizers committed a greater crime against him.
- ➤ On September 9, 2024: An armed colonizers from the so-called "Zohar" colonial outpost attacked students of "Kaa'bneh Bedouin School" in Arab al-Malihat community northwest of the city of Jericho, preventing them from accessing their school, and causing them panic and fear.
- ➤ On September 13, 2024: A number of colonizers attacked the lands of "Beit Imrin" village, west of Nablus, cut down a number of olive trees, demolished two agricultural rooms, water tanks, and stone chains surrounding the lands.
- ➤ On September 13, 2024: A number of colonizers attacked agricultural lands in the village of Jaba', south of Jenin, near the so-called "Homesh" colony,

which was forcibly established on citizens' lands. They uprooted dozens of olive trees and demolished an agricultural room. Notably worth, since the Israeli occupation government's decision last year to



return colonizers to the so-called "Homesh" colony after it was evacuated in 2005, the colony has been used as a starting point for them to carry out their attacks on citizens, their lands, homes and properties in the area.



On September 16, 2024: A group of colonizers, under the protection of the occupation forces, stormed Al-Hilweh Street in the town of At-Tur, east of occupied Jerusalem. They raided a residential apartment, locked its doors, placed barbed wire around it, and installed surveillance cameras.

> On September 16, 2024: a group of armed colonizers attacked al-Kaa'bneh


Arab community in al-Ma'rajat area northwest of Jericho, assaulted an elderly man, and stormed the elementary school. They attacked the students and teachers before detaining them. A





state of panic and fear spread among the citizens, especially women and children. The occupation forces arrived and arrested the school principal and one of the students' parents. Red Crescent crews dealt with 3 injuries caused by the colonizers' attack, and they were transferred to the hospital for medical treatment.

➤ On September 18, 2024: a group of colonizers from the so-called "Mitzpe Yair" colony, under the protection of Israeli occupation force, severely beat the young man Muhammad Dababseh in the village of Khallet al-Daba' in Masafer Yatta, while was grazing sheep on his land. The armed colonizers ambushed him (hiding behind trees) and severely beat the citizen with five strong sticks, causing him injuries and



bruises, after which he was transferred to the hospital for treatment.

- ➤ On September 20, 2024: a group of colonizers attacked citizens in Khirbet Tana, east of Nablus, and expelled them at gunpoint. They assaulted the residents, prevented them from accessing the water spring, and expelled them from the area, under the protection of the Israeli occupation forces. It was reported that the colonizers threatened to open fire if the citizens remained in the area.
- ➤ On September 22, 2024: extremist colonizers poisoned the sheep belonging to the citizen Abdul Karim al-Jabari east of the city of Hebron. As a result of that, five of them were killed. The colonizers also attacked citizens' homes in al "Ja'bara" area east of the city, where the extremist minister Itamar Ben Gvir lives, and his home is only a few meters away from the homes that the colonizers attacked.

- ➤ On September 23, 2024: For the thirteenth consecutive day, the colonizers continued to bulldoze lands in the villages of Umm Safa and Arora, northwest of Ramallah. The colonizers, under the protection of the occupation army, bulldozed about 500 dunums of lands in the two villages, shut off the road between the village and the village of Deir Sudan, and prevented citizens from passing. In recent days, residents have been subjected to continuous gunfire from the colonizers if they try to object to the bulldozing operations targeting Jabal al-Ras in the village.
- ➢ On September 23, 2024: A group of colonizers bulldozed lands in the Bir Abu Ammar area, northwest of the town of Qarawa Bani Hassan, west of Salfit. It is worth mentioning that this area is considered a tourist, recreational and archaeological area for the



people of Qarawa Bani Hassan, as horse competitions and shows and many sports games were held there.

September 25, 2024: A group of colonizers set up tents on citizens' lands in the village of Umm Safa, northwest of Ramallah. This coincides with the ongoing bulldozing operations for more than a month and the systematic land seizure operations in "Jabal al-Ras", where colonizers, under the protection of the occupation army, bulldozed about 450 dunums of land from the villages of Umm Safa and Arora, northwest of Ramallah. they blocked the road extending between the villages of Deir Sudan, Arora and Umm Safa, and prevented citizens from passing, in a systematic seizure mechanism implemented by the occupation state these days targeting the northwestern

section of the Ramallah Governorate, in order to cut off communication between the villages of the region and the governorates of the northern West Bank in favor of a large colonial project being prepared to be implemented there.






➤ On September 29, 2024: a group of colonizers set up two tents and water tanks on the citizens' lands in the "Shaab al-Ajel" area in the town of al-Khader, south of Bethlehem, with the aim of establishing an agricultural outpost.

Second: Procedures and Practices of the Occupation Authorities against Palestinian Institutions

a. Demolitions

According the to Colonization Wall and Commission Resistance violations (CWRC) database, during the period covered by the report, September 2024, the occupation authorities




carried out a total of 100 demolitions that targeted 116 institutions in the West Bank, including Jerusalem. Most of these demolitions were concentrated in the Hebron Governorate, with 53 demolitions that resulted in the demolition of 58 institutions, followed by the Jerusalem Governorate, with 16 demolitions, which resulted in the demolitions of 21 institutions.

The side graph illustrates the distribution of demolition operations in the southern and northern regions of the West Bank. Because the relationship between demolitions and demolition notifications is inherent (see the notifications section), we notice the concentration in both the northern and southern parts of the West Bank. These notifications are concentrated in vast areas where the Israeli occupation seeks to evacuate and forcibly depopulate in favor of the settler-colonial project. In the period covered by the report, these demolitions included: inhabited residences, uninhabited residences, residences under construction, agricultural facilities, mobile homes (caravans), industrial and commercial barracks, and water wells.



The following is a comparison of the number of demolitions and demolished facilities carried out by the Israeli occupation authorities in the West Bank governorates during the past three months



b. Notifications (Demolition, Construction Moratorium, Evacuation)

During the period covered by the report, September 2024, the Israeli occupation authorities issued 30 notifications. These notifications varied demolition between notifications,



construction moratoriums under the pretext of lacking a license, or evacuations under the pretext of conducting military training. Most of these notifications were concentrated in the Salfit Governorate with 23 notifications, followed by the Jerusalem Governorate with 4 notifications.

The notifications issued by the Israeli occupation authorities in the West Bank serve as a means of besieging Palestinians in Area "C" and obstructing their development and urban expansion since the occupation controls planning in those regions and hinders the Palestinians' right to prepare and approve master plans. Such measures aim to exploit Area "C", representing 61% of the West Bank's total area, for future colonial expansion and strategic purposes.

Third: Expropriation: Land Confiscation

In the past September, the Israeli occupation state seized 857,445 dunums of citizens' lands in the governorates of Tubas, Tulkarm, Hebron, Nablus, Qalqilia, and Jericho through 10 military orders. These orders aim at imposing a new reality under the pretext of security and military purposes.

The first order targeted 7.739 dunums of land in Beit Lid in the Tulkarm Governorate. The purpose of the confiscation was to establish a security road connecting Einav colony to the main road by joining a secondary road in the area. This military order was numbered T/71/24.



The second order targeted 732.719 dunums of land in the villages of Bardala and Tayaseer in the Tubas Governorate. The purpose of this order is to reorganize a military site established in the area, as indicated in red on the military order map. This involved cancelling a previous order controlling 275 dunums, highlighted in yellow, and replacing it with the new order that intersects with Road No. 5799. This military order was numbered T/79/25.




The third order targeted 6.712 dunums of the lands of the city of Tubas to isolate the lands surrounding the Maskiot colony, established on citizens' lands in the Tubas Governorate, to complete the establishment of a buffer zone. This military order was numbered T/81/24.



The fourth order targeted 2.791 dunums of land in the city of Tubas. This order aims to establish a security strip connecting the Nahal Betronot colonial outpost, built on citizens' lands in Tubas, to Road No. 90 in the area. This military order was numbered T/80/24.



The fifth order targeted approximately 18 dunums of citizens' land in the villages of Burin, Madama, and Asira al-Qibliya in the Nablus Governorate. Upon reviewing the military order and the attached maps, it became clear that the occupation authorities aimed to establish a buffer zone around the Yitzhar colony, which, in addition to confiscating the specified 18 dunums, would prevent citizens from accessing hundreds of dunums surrounding the colony from all directions. This military order was numbered T/73/24.



The sixth order targeted approximately 0.767 dunums of citizens' land in Masafer Yatta in the Hebron Governorate. The military order aims to establish a wall 767 meters long on the southeastern side of the Karmel colony built on citizens' lands in Masafer Yatta. This military order was numbered T/75/24.



The seventh order targeted approximately 2.734 dunums of citizens' land in Qalqilia. The military order aimed at expanding the existing military site on lands east of Qalqilia at the main entrance intersecting with the Tzufim colony. This military order was numbered T/82/24.



The eighth order targeted approximately 8 dunums of citizens' land in the village of Fasayil in Jericho and the Jordan Valley. The military order aimed at adding a segment of a new security road linking the Tomer colony south of Fasayil to Road No. 90 in the Jericho Governorate. This military order was numbered T/79/24.



The ninth order targeted 57.252 dunums of citizens' land in the village of Kafr Qaddum in the Qalqilia Governorate. The military order aims to create a buffer zone around the Kedumim colony. This military order, numbered T/65/24, is valid until December 31, 2028. The military order shown in the attached map is positioned around the Kedumim colony to the east of Kafr Qaddum and intersects longitudinally with Road No. 55. The danger of this military order lies in denying citizens access to hundreds of dunams surrounding the colony that fall within the

specified order.



The tenth order targeted 20.834 dunums of land in the villages of Mas'ha in the Salfit Governorate and Sineria in the Qalqilia Governorate under a military appropriation order. This order, numbered T/6/24, is valid until December 31, 2028, and aims to establish a security road between the Annexation and Expansion Wall and the lands of the villages of Sineria and Beit Amin, as specified in the attached map.



Fourth: Colonial Expansion Plans (Approved and Deposited)

In September, the Israeli occupation authorities studied a total of 20 master plans

(approval and deposit) for the purpose of expanding colonies in the West Bank and Jerusalem. This includes the approval of 11 master depositing plans and others. The plans targeting the West Bank aim to build a total of 1,131 colonial units on an area estimated at 898 dunums of citizens' land, while the plans for the city of Jerusalem aimed to build 1,620 colonial units on an



area estimated at 106 dunums of citizens' land. Upon reviewing the maps of the plans and the attached files, it became evident that the occupation intends to build a new colonies on the lands of the Ramallah Governorate, specifically on the lands of the villages of Al-Medya and Ni'lin, by announcing the expansion of the settlement of Gnei Modi'in (Hashmonaim) – see side map².

Master plan no. יוש / 3/ 3/ 208 aims to build 150 new colonial units on an area estimated at 111 dunums. This plan targets lands geographically far from the borders of the colony, in an evident attempt of trickery by the occupation state to avoid announcing the construction of a new colony by claiming to carry out expansion operations.

Fifth: The Most Prominent Examples of the Incitements and Racist Statements by the Occupation State Leaders

These days, leaders of the Israeli occupation started making their racist statements unabashedly, revealing their superiority complexes and racist stances. In this section of the report, we quickly review the most prominent statements.

- September 30, 2024: The Israeli Minister of Colonization, Orit Strook, stated in a post on "X" that "Palestinian evil proves once again to be dangerous in itself, and we, as a government, must at least demonstrate our ability to inflict lethal damage on the diplomatic terrorism directed against us."
- Likewise, Finance Minister Bezalel Smotrich from the Religious Zionism party posted on "X": "I have just completed a long tour in the agreed-upon reserve in the Judean Desert, east of Gush Etzion. There is a massive strategic event taking place here. The Palestinian Authority is making concentrated efforts with a lot of money and energy to gain control to the east, to create regional continuity from north to south, as well as from east to west, effectively cutting off our continuity. This poses a significant threat to the landscape in one of the most valuable and important areas in the State of Israel."
- September 16, 2024: Itamar Ben Gvir, the so-called "Minister of National Security" (Jewish Power), posted on his platform: "It's sad that on the day we bury soldiers, we must confront a petition from a Knesset member in the State of Israel, who receives his salary from us, wanting to meet and talk with our partner—Marwan Barghouti, a killer whose hands are stained with Jewish blood. This is a disgrace, I say it plainly. I am the political level; I am the one who decided they cannot meet, and I stand behind this decision."

- On his part, Bezalel Smotrich, Minister of Finance (Religious Zionism), stated: "We are forced to work to uproot the phenomenon of criminal terrorism in the Arab community in Israel, which primarily affects the Arab community itself, including innocent children and infants. We are talking about quantities of weapons, explosives, and materials that pose a national danger, some of which are already flowing to the perpetrators in Judea and Samaria and could be directed against every citizen in Israel in a future conflict."
- Ehud Tal, a Knesset member from Religious Zionism, added: "The time has come to change direction and adopt the 'Heroes' Plan!' (A plan initiated by a group of reserve soldiers aimed at forcing the residents of northern Gaza to completely evacuate to the central region, allowing displaced Israeli colonizing families to return to the colonies they were evacuated from during the aggression on Gaza)."
- Danny Danon, Israel's ambassador to the United Nations, posted: "How surprising—'UNRWA workers' who were killed yesterday during an IDF attack are actually 9 terrorists with blood on their hands, some of whom participated in the barbaric massacre on October 7. How long will the United Nations continue to bury its head in the sand and ignore the fact that Hamas terrorists have taken over UNRWA? These dead are not aid workers; they are terrorists with blood on their hands who are doomed to death."
- Yisrael Katz, Minister of Foreign Affairs (Likud), posted on his platform: "In the same week that the United States, Germany, France, and the United Kingdom imposed sanctions on Iran's air relations after it supplied missiles threatening Europe, the outgoing High Representative of the European Union for Foreign Affairs, Josep Borrell, was busy with hate campaigns against Israel."

- September 9, 2024: In a provocative article on X, Knesset member Avigdor Lieberman from Yisrael Beiteinu incited against sending aid to the Gaza Strip, stating: "Unbelievable: Israel is suffering from a potato shortage because a large quantity was sold to Gaza. The Ministry of Agriculture's response is even more ridiculous; we asked to regulate the quantity sold to the sector to keep the shelves in Israel full. This oxygen tube must be stopped immediately—no food products, no cigarettes, and no other concessions."
- For her part, Minister of Colonization Orit Strook called for depriving citizens of access to the main roads between cities and villages, saying: "A million Israeli travellers on the roads of Judea and Samaria deserve clean roads free of terrorism. This is logical and necessary: those who are not allowed to enter little Israel should not be allowed to travel before, after, or through Judea and Samaria. This is easy and straightforward: there is a complete system of alternative roads; the decision is needed, and immediately!"
- Orit Strook, Minister of Colonization and National Missions, also stated on X: "Enough with the discrimination between blood and blood! The hammer operation must be the dividing line: whoever decides on the entry of Palestinian workers into little Israel will also decide on their entry and the conditions for their access to industrial areas in Judea and Samaria. The small ministerial council is called to take charge and manage the situation."
- In response, Itamar Ben Gvir, so-called "Minister of National Security" (Jewish Power), tweeted about his support for the police, which issued a notice prohibiting the screening of the film "Jenin Jenin" by artist Mohammed Bakri. He said: "I commend the Israel Police and the incitement prevention team I established for their persistence and implementation of policies: the anti-Semitic film 'Jenin Jenin' by Mohammed Bakri should not be shown, neither

- in Haifa, nor in Jaffa, nor anywhere in the State of Israel. The days when inciters and supporters of terrorism could do as they please are over."
- Yisrael Katz, Minister of Foreign Affairs (Likud), tweeted on X: "The Israeli Defense Forces are, as of tonight, operating in the Jenin and Tulkarm refugee camps to thwart the Islamic-Iranian terrorist infrastructure that has been established. Iran is working to establish an eastern terrorism front against Israel in Judea and Samaria, following the Gaza and Lebanon model, by financing and arming perpetrators and smuggling advanced weapons from Jordan."
