**Foreword:** 

The issuance of the monthly report on the most prominent Violations of the Israeli

Occupation State & Colonizers in the Occupied Palestinian Territories in October

2024 coincides with the current olive season. This season is experiencing an

unprecedented wave of terrorist attacks prepared by the official institutions of the

occupying state, as they unleash settler militias on the defenseless farmers in their

lands. By targeting the olive season, the Israeli occupying state aims at undermining

the deep emotional connection between the Palestinian people and their land.

Everything currently being pursued by the occupying state is part of a clear plan to

weaken this relationship, control Palestinian territory, and prevent citizens from

accessing their land.

The steadfastness of Palestinian citizens in remaining on their land and their

determination to work in the olive fields have disrupted the colonizers' plans. This

perseverance highlights the courage of the Palestinian landowners, who refuse to

leave his land or retreat.

The Colonization and Resistance Commission (CWRC), along with partner

institutions and popular committees, has enabled citizens to access vast areas that

colonizers' militias had closed off for years in preparation for their control. This

effort, part of the national olive harvest campaign, emphasizes that the success of

this season has ultimately thwarted the occupation's plans.



# First: Violations of the Israeli Occupation State & Colonizers in the Occupied Palestinian Territories during October 2024:

During the reporting period, October 2024, the Colonization & Wall Resistance Commission (CWRC) monitored 1490 attacks. These attacks were carried out by the various bodies of the occupying state, including its colonial militia, against Palestinian citizens and their properties.

These attacks included assaults and physical injuries, caused by live ammunition, gas, or terrorism. They also involved raids. vandalism. theft. confiscation. property land bulldozing, and tree uprooting.




However, the majority of these attacks occurred in the governorate of Nablus which witnessed 307 attacks. This was followed by Hebron Governorate (280 attacks). There were also numerous attacks in the other West Bank governorates. These governorates experienced intensive attacks, amounting to 52% of the total attacks.

These included 361 attacks on property and religious sites, 69 attacks on lands and natural resources, and 1060 attacks on citizens.

# Attacks perpetrated by Israeli Occupation State & Colonizers against Palestinian citizens, their properties and holy places.

#### **Attacks on citizens:**

During the reporting period, October 2024, Colonization & the Wall Resistance Commission (CWRC) documented 1060 attacks on citizens. Most of these attacks were concentrated in **Nablus** Governorate



which witnessed 199 attacks, followed by Hebron Governorate which witnessed 174 attacks. These attacks included shooting, arrest campaigns, shutting down checkpoints and imposing traffic restrictions on citizens.



#### **Attacks on Lands & Natural Resources:**

During October 2024, the Colonization & Wall Resistance Commission (CWRC)

has documented 69 attacks on the Palestinian lands and natural resources. These attacks were concentrated Nablus Governorate which witnessed 19 attacks, followed by Ramallah Governorate (13 attacks).



Meanwhile, 12 attacks were recorded in Hebron governorate.

These attacks affected hundreds of dunums of citizens' lands. During The reporting period, October 2024, there were 7 attempts by colonizers to establish colonial outposts on citizens' lands. Additionally, the occupation authorities and colonizers carried out 11 bulldozing lands' operations. These operations were concentrated in Nablus Governorate, where 4 bulldozing lands' operations took place, followed by Hebron which witnessed 2 bulldozing lands' operations<sup>1</sup>.

#### **Attacks on Trees:**

During the reporting period, October 2024, the Colonization & Wall Resistance Commission (CWRC) documented 51 attacks that targeted olive trees and caused the uprooting, poisoning and burning of 1401 trees among which there were 1339 olive trees. These attacks were concentrated in Nablus governorate which witnessed 15 attacks, followed by Ramallah govenorate which witnessed 12 attacks. Meanwhile, 7 attacks were recorded in Hebron govrornorate.

#### **Attacks on Palestinians' Properties:**

In October 2024. the Israeli occupation forces and colonial militias launched aggressive campaigns to confiscate, steal, and vandalize citizens' possessions. The targeted properties included agricultural tractors, vehicles.



bulldozers, camera recordings, money, bulldozers, electrical equipment, water pumps, olive crops, agricultural equipment, fuel tanks, livestock, olive harvesting equipment, a caravan and a tent, mobile phones, an electric generator, and solar cells. During the reporting period, October 2924, 361 attacks on properties were documented. These attacks caused the confiscation, vandalism, and theft of about 281 Palestinian properties. Specifically, Israeli forces confiscated 18 vehicles, a camera recordings, 5 agricultural tractors, 4 bulldozers, 4 cases of confiscating

electrical equipment (3 mobile phones and a carpentry equipment), 4 water pumps, 8 cases of confiscating olive crops, 5 cases of confiscating agricultural equipment, confiscating fuel tanks, as well as they were involved in 3 cases of stealing money during inspections (about NIS 105 thousand).

Meanwhile, the colonizers were involved in the theft of: 5 donkeys, 2 camels, 22 cases of stealing olive harvesting equipment, 26 cases of stealing olives, 3 cases of stealing vehicles, 15 tents and caravans (residential and agricultural) with all their contents, as well as they were involved in 3 cases of stealing money from a citizen's car (NIS 3000), stealing 2 cell phones from citizens, an electric generator, and two cases of stealing solar cells for generating energy.

#### **Colonizers' Attacks:**

According to what was monitored and documented by the Colonization and Wall Resistance Commission (CWRC) during the reporting period, October 2024, the colonizers carried out 360 organized attacks.


These attacks varied between the occupation army's protection of the colonists in their storming of Palestinian cities and communities, breaking into Palestinian villages, confiscating citizens' property, drawing racist slogans on the walls, and bulldozing lands, as what happened in the villages of Qusra and Battir.

Furthermore, 34 vehicles were badly attacked, either by damaging or vandalism. Including the affected vehicles, there were 28 smashed and vandalized vehicles, 3 vehicles were set on fire and 3 vehicles were exposed to gunfire in addition to throwing stones at the passing vehicles as well as the racist graffiti that were drawn on these vehicles.

The most prominent of these colonial attacks was storming the holy places; among which was the squares of Al-Aqsa Mosque in the occupied city of Jerusalem. During the reporting period, October 2024, 9773 Israeli colonizers, protected by the occupation army, carried out 21 raids into Al-Aqsa Mosque Squares. Besides, 3269 colonizers carried out provocative tours under what is called "tourism to the squares


of Al-Aqsa Mosque".

Notably worth, most of these attacks were concentrated in Nablus Governorate which witnessed 108 attacks, followed by Hebron Governorate where 81



attacks were recorded. Meanwhile, 48 attacks were documented in Ramallah Governorate.

A comparison between the number of colonizers' attacks in the West Bank governorates over the past three months:



#### **Examples on the Colonizers' Attacks:**

- ➤ On October 2, 2024: a group of colonizers headed by the guard of the so-called "Yitzhar colony" attacked farmers in "Al-Lahf "area in the town of Huwwara, south of Nablus, and assaulted them. As a result of this attack, two citizens suffered from bruises and wounds, namely Saqr Khaled Odeh and Jamil Fayez Odeh, who were transferred to "Huwwara Emergency Center". The colonizers also seized olive harvest equipment after attacking the farmers and forcing them to leave their lands.
- ➤ On October 7, 2024: a group of colonizers placed a Star of David sign at Auja Spring, located north of Jericho. They fixed the sign along a watercourse in Auja to assert their control over the spring.



➤ On October 11, 2024: A group of colonizers attacked the house of the citizen Nader Abu Kamil in the village of Khalayl Al-Loz, southeast of Bethlehem. They smashed its doors and windows, raised the flags of the occupying state around the house, and cut down 20 olive trees.



- ➤ On October 12, 2024: Armed Israeli colonists launched an attack on olive pickers in various areas of the village of al-Mughayyir, located northeast of Ramallah. The incidents occurred particularly in the plain area known as Marj Al-Dhahab, as well as in Al-Hajjar and Al-Rafid. The colonists attempted to prevent the residents from harvesting their olives, but the local community managed to force the attackers to flee.
- ➤ On October 17, 2024: Armed colonizers attacked participants in an event, organized by the Colonization & Wall Resistance Commission (CWRC), aimed at assisting farmers from the village of Kafr Labad in their olive harvesting efforts. The head of the Commission, Minister Mu'ayyad Shaa'ban, participated in the event, in addition to representatives of a number of official and civil institutions. The colonizers fired live bullets and tear gas canisters at the participants, and forced them to leave the area.
- ➤ On October 17, 2024: Israeli colonists attacked Palestinian farmers while they were harvesting olives in Ramin Valley, located east of Tulkarm in the occupied West Bank, forcing them to leave their lands under threat of violence. One of the colonizers, dressed in military attire and armed, broke into the area and prevented them from continuing their work. He brought his livestock to the fields in a provocative act against the farmers. This colonist

had previously seized vast areas of the valley's land and established a colonial outpost. He regularly attacks the farmers while they are working, forces them to vacate the area. In addition, colonists from the nearby "Anab" colony occasionally attack the plains, burn and uproot the trees.

- On October 17, 2024: Colonizers caused a power outage in the village of Yasuf, east of Salfit. It was reported that colonizers from the so-called "Taffuh" colony, built on citizens' lands, vandalized the electrical facility at the eastern entrance, causing a blackout in the entire area.
- ➤ On October 18, 2024: a group of colonizers assaulted a 15-year-old boy named Ahmed Abdel Fattah Muhammad Zidan while he was at "Shaqif Danan" farm in Wadi Qana, located northwest of Deir Istiya. The incident occurred when they raided the farm, during which they not only attacked the child but also stole an electric generator and damaged bags of barley and bran.



➤ On October 18, 2024, a group of colonizers stole a tent and furniture belonging to the citizen Muhammad Younis Abu Aram during an attack on the areas of Al-Fakhit and Al-Halawa in Masafer Yatta, located south of Hebron. This attack included a raid on Al-Fakhit Mixed School. Abu Aram noted that the number of colonizers' attacks has increased in Masafer Yatta, particularly in Khirbet Al-Halawa, where they recently established two tents and a sheep farm. Additionally, they took control of a water well belonging to

the citizen Ismail Abu Aram near the village's lands, seemingly to force local residents to abandon their properties and displace them from the area.

➤ On October 20, 2024, the Israeli occupation forces and their colonizers suppressed an event held in support of farmers who are being attacked by colonizers in the village of Burqa, located east of Ramallah.

About 200 volunteers, foreign



activists, and several diplomatic members participated in this event. It was organized by the Colonization & Wall Resistance Commission (CWRC), alongside the Ministry of Agriculture to support the farmers in Burqa as they faced assaults from colonizers and the occupation army while picking olives.

- ➤ On October 22, 2024, group of colonizers established a new colonial outpost on the lands of "Farkha" village, located southwest of Salfit. Under the protection of the Israeli occupation forces, the colonizers began establishing this outpost in "Al-Batin" area, west of Farkha. They brought building materials and caravans to the site. This outpost is considered as an extension of the so-called "Ariel" colony and is expected to cover an area of about 1,250 dunams. The confiscated land is surrounded by around 800 dunams of olive trees and includes a water spring that provides 40% of the citizens' consumption of water. Additionally, there is a Bedouin community in the area that is at risk of forced displacement. The occupation forces began preparing the site and constructing a new road leading to the area several months ago.
- ➤ On October 23, 2024, a group of colonizers demolished the residential facilities in "Jurat al-Khail" colony, located east of Sa'ir and southeast of Hebron. They seized and completely destroyed the contents of more than 15

facilities after forcibly evacuating the owners two days prior. A group of colonizers from the so-called "Asfar" and "Odovim" colonies carried out this demolition. The residents were unaware that the demolition had occurred until one of them returned to the area to check on their homes and belongings, which had been left behind due to escalating settler attacks. The resident reported that over 15 homes and facilities were demolished, and all personal belongings—including clothing, furniture, windows, and doors—were seized. In addition, more than 20 solar energy units along with their batteries were taken and destroyed. The Fifteen families who lived in the community were forced to leave under the threat of armed colonizers. Recently, dozens of colonizers, some wearing military uniforms, stole 300 sheep from the community. It is noted that this area has faced demolition before; the first time occurred in 2016.

- ➤ On October 10, 2024, two women were injured after being assaulted by colonizers near "Deir Sharaf" roundabout, northwest of Nablus. Ambulance crews transported the women, aged 54 and 42, to the hospital after they sustained bruises and wounds after the colonizers assaulted them and sprayed them with pepper gas.
- On October 28, 2024,
   a group of colonizers
   attacked Al Kaa'bneh Mixed
   Elementary School,
   located in "Arab Al Malihat" community
   northwest of Jericho.






Armed colonizers vandalized the school by smashing the windows of

classrooms and attempting to destroy the newly installed surveillance cameras, which were still being prepared for use. This School, which is located in Al-Mu'arrajat area that connects the Ramallah and Al-Bireh governorates with Jericho, is recognized as a challenge school and serves 100 male and female students. It has faced repeated attacks by colonizers, the most recent of which was in mid-September.

### > Second: Procedures and Practices of the Occupation Authorities against Palestinian Facilities

#### a. Demolitions

According the to Colonization Wall and Resistance Commission (CWRC) violations database, and during the reporting period, October 2024, the Israeli authorities occupation carried out 34 demolitions




that targeted 45 facilities in the West Bank, including Jerusalem. Most of these demolitions were concentrated in Hebron Governorate, which witnessed 11 demolitions that resulted in the demolition of 16 facilities followed by Salfit Governorate, where 4 demolitions were monitored and resulted in the demolitions of 8 institutions. Meanwhile, 4 demolitions were recorded in the governorates of Bethlehem and Jerusalem and caused the demolition of 4 facilities in each of them. The side graph shows that demolition operations are concentrated in the southern and northern regions of the West Bank. Because the relationship between demolitions and demolition notifications is inherent (see the notifications section), we notice the concentration (of both demolitions and notifications) in both the northern and southern parts of the West Bank. These notifications are concentrated in vast areas where the Israeli occupation seeks to evacuate and forcibly depopulate in favor of the settler-colonial project. During the reporting period, these demolitions included: inhabited residences, uninhabited residences, residences under

construction, agricultural facilities, mobile homes (caravans), industrial and commercial barracks, and water wells.

The following is a comparison of the number of demolitions and demolished facilities carried out by the Israeli occupation authorities in the West Bank governorates during the past three months.




#### **b.** Notifications (Demolition, Construction Moratorium, Evacuation)

During the period covered by the report, October 2024, the Israeli occupation authorities issued 38 notifications. These notifications varied between demolition notifications, construction moratoriums under the pretext of lacking a license, or evacuations under the pretext of conducting military training. Most of these notifications were concentrated in the Jenin Governorate with 17 notifications, followed by the Jericho Governorate with 8 notifications, and the Jerusalem

Governorate with 7 notifications.

The demolition notifications issued by the Israeli occupation authorities in the West Bank serve as one of the means it utilizes to restrict Palestinians in Area "C" and obstruct their development and urban expansion. In light of



the occupation's control of planning in these areas, they deny Palestinians their right to prepare master plans. Even when these master plans were submitted, they were rejected, preventing Palestinians from utilizing Area "C", which constitutes 61% of the West Bank. This area is being kept for the expansion of colonies and as a strategic reserve for future use.

#### Third: land Expropriation orders (Land Confiscation)

Last October, the Israeli occupation state seized 83.705 dunums of privately owned Palestinian lands in the governorates of Jerusalem, Jenin, and Salfit through 3 military orders. These orders aim to impose new realities under the pretext of security and military purposes.

**The first order** targeted a total of 26.499 dunums of citizens' lands in the village of Jaba' in the Jerusalem Governorate. This order aims to create a buffer zone around the colony of Geva Binyamin on the lands of the governorate. The military order carried the number T/24/69 and is valid until December 31, 2027.

**The second order** targeted a total of 3.259 dunums of citizens' lands in the village of Barta'a in the Jenin Governorate. The order aims to construct a security road to attach the Rehan colony to colonial road no. 596. The military order, numbered T/85/24, is valid until December

**The third order** targeted a total of 53.947 dunums of citizens' lands in the village of Kifl Haris and the city of Salfit in the Salfit governorate. The order aims to construct a road connecting the entrance of Salfit city to the main road, effectively denying the residents of Salfit governorate access to the main road designated for the city. The military order, numbered T/90/24, is valid until December 31, 2027. **Typically, land seizures for the purpose of constructing roads are carried out** 

Typically, land seizures for the purpose of constructing roads are carried out under expropriation orders. However, this time, they were seized through a temporary seizure order (valid until 12/31/2027). After consulting various sources and references, it became evident that the occupation army is circumventing citizens who might challenge the order in court by claiming that the confiscation is for security considerations. In truth, the military order aims to control the course and outcomes of the road under the pretext of security and military needs, avoiding citizen objections over the closure of the first road, which has been designated exclusively for colonizers, while opening the second road.

# Fourth: Laws and Bills proposed or approved by the Israeli Knesset in October 2024

In this part of the report, we review the most prominent of the laws and bills that were studied in the Occupation's Knesset. Considering the nature of these laws, their hostile and racist nature can be inferred, through which the legislative bodies in the occupation state seek to entrench a system of suppression against Palestinians or to perpetuate the racial segregation and apartheid imposed on them. More recently, the occupation started exploiting the conditions of war and emergency laws to create a new reality that cannot be reversed, according to the Israeli description.

An example of the aforementioned is the two laws approved in their final reading, concerning the ban of UNRWA's activities. The first law states: "The purpose of the law is to prohibit all activities of the UNRWA within the territories of the State of Israel."

"UNRWA shall not establish or operate any representation, provide any services, or engage in any activities, directly or indirectly, within the sovereign territory of Israel."

The second law stipulates the annulment of the existing agreement between Israel and UNRWA, signed on June 14, 1967.

The (Israeli) Foreign Minister must notify the United Nations of the termination of the agreement with UNRWA within seven days of the law's enactment. The law prohibits any state authority, including entities, institutions, and individuals carrying out public duties under the law, from engaging in any contact with UNRWA or any of its affiliates. The law also stipulates that its provisions do not preclude criminal proceedings against UNRWA employees, including those related to the events of October 7, 2023, the "Iron Swords War" (the war on Gaza), or any criminal action under the (Israeli) Counterterrorism Law of 2016, nor do they prevent taking action against these employees.



#### **Fifth: Colonial Expansion Plans (legalizing Outposts)**

In October 2024, the Israeli occupation authorities submitted 15 master plans

(approval and deposit) to expand colonies in the West Bank and Jerusalem. This includes the approval of 7 master plans and the depositing of 8 others. The plans targeting the West Bank aim to build a total of 1,151 colonial units on an area estimated at 584 dunums of citizens' land, while the plans for the city of Jerusalem aimed to build 500 colonial units on an area estimated at 107 dunums of citizens' land.



Upon reviewing the maps of the plans and the attached files, it became evident that the occupation intends to "legalize" a new colonial outpost through plan number איזש' 8/ 237, considering it a new colonial neighborhood affiliated with the Eli colony, located on the lands of citizens south of Nablus Governorate – see the side map.<sup>2</sup>

#### Sixth: Racist Statements/ Discourse by members of the Israeli Government

These days, leaders of the Israeli occupation started making their racist statements unabashedly, revealing their superiority complexes and racist stances. In this section of the report, we quickly review the most prominent statements.

- October 7, 2024: The extremist Israeli so-called "Minister of National Security", Itamar Ben-Gvir, posted an inciting post on the X platform, encouraging and supporting the detention of martyrs' bodies. The post stated: "I applaud the Supreme Court's refusal to interfere in the ministerial council's decision, which aligns with my stance that we should continue holding the bodies of Israeli Arab terrorists, especially the loathsome terrorist Walid Daqqa."
- On the same day, the Israeli so-called Minister of Foreign Affairs posted an inciting post. The post stated: "Today I decided to declare that the UN Secretary General, António Guterres, persona non grata, and that a person who fails to unequivocally condemn Iran's heinous attack, like nearly all countries of the world did, s not worthy of stepping on Israeli soil"
- The Israeli Minister of Housing and Construction in the Israeli government, Yitzhak Goldknopf, posted an inciting post against the "UNRWA" agency on platform X, stating: "We prefer the terrorist organization UNRWA to be in danger rather than the people of Israel. In response to my directive to evacuate UNRWA from state lands, we will do everything we can to expel this terrorist organization and its activists from the lands of the State of Israel."
- On October 14, 2024, the extremist Israeli so-called "Minister of National Security", Itamar Ben-Gvir, published an inciting post on the platform X against Palestinian detainees. In it, he wrote: "On 10/7 at five in the morning,

I participated, along with the Prison Service Commissioner Kobi Yaakobi, in a prison raid on the cells of the terrorists, some of whom are elite terrorists who planned to instigate riots within the prison on the anniversary of the October 7 massacre. The only way to deal with these vicious animals is with an iron fist. This is the policy of the Prison Service. This is what happened, and this is how it will continue under my tenure!"

- In another inciting post, the extremist Finance Minister Bezalel Smotrich on platform X stated: "I have secured my place in the Ministerial Council and the Israel Defense Forces, and instructions have been issued to take control of aid in the northern part of the Strip. Better late than never."
- On platform X, Israel's Ambassador to the United Nations, Danny Danon, posted: "The Security Council is now holding an urgent discussion on the situation in Gaza. During my speech, I intend to criticize the Council for holding this discussion at all, especially with the one-year anniversary of the October 7 massacre and while 101 hostages are still in Gaza. I will clarify to the ambassadors that only when Hamas is no longer in Gaza will aid reach exactly everyone who needs it."
- On October 21, 2024, MK Almog Cohen from the Jewish Power party made a statement on platform X regarding detainees and their families, saying: "We cannot continue to show weakness toward those who call for the killing of our citizens. There is no intention of stopping. This morning, we will discuss the 'Expulsion of Terrorists' Families' law, which is being fast-tracked for legislation and is expected to pass its third reading by the end of October. If the Supreme Court dares to overturn the law, it will result in an unprecedented legal crisis."
- MK Limor Son Har-Melech from the "Jewish Power" party also criticized the Israeli Supreme Court for merely requesting an explanation on "why the

wounded from Gaza are not being transferred to a third country." In a post on the platform X, she stated: "The Supreme Court has once again proven that it is completely detached from reality; this explanation is a slap in the face to the families of the dead and kidnapped. The Court must understand that there are no uninvolved people in Gaza."

- MK Tzvi Sukkot from the "Religious Zionism" party criticized the marches and demonstrations in Israel calling for a ceasefire agreement and the release of prisoners. In a post on platform X, Sukkot claimed that the solution lies in several key points, most notably: military pressure, taking responsibility for the distribution of humanitarian aid, halting the activities of all relief organizations unless they coordinate with the Israeli occupation army or leave the Strip, and expanding the security perimeter day by day at the expense of homes in the Strip.
- The Minister of Construction and Housing, Yitzhak Goldknopf, posted on platform X against the United Nations Relief and Works Agency for Palestine Refugees (UNRWA), stating: "I am pleased that, thanks to my directives to evacuate UNRWA from the location (Jerusalem), the complex that once hosted an organization supporting terrorism will become a thriving Jewish neighborhood where boys and girls will play in its courtyards. The new neighborhood established in the complex will strengthen Jewish settlement in the city of Jerusalem
- Benny Gantz, a minister in the "Cabinet," criticized the CBS network in a post on platform X after it instructed its reporters not to "mention Jerusalem as part of Israel." He said: "Jerusalem's status is not up for debate; it is clear and explicit — the eternal capital of the Jewish people. This has always been the case and always will be, and no amount of disregard or attempt to distort reality will change that."

- MK Avigdor Lieberman from the "Yisrael Beiteinu" party, continued incitement against Gaza, posting on his account on platform X: "The Israeli government must immediately stop the entry of all humanitarian aid, fuel, electricity, and water to Hamas in Gaza and tightly close the crossings. There is no justification for aiding terrorists."
- MK Tally Gotliv from the "Likud" party attacked the Israeli Supreme Court for issuing a conditional order to clarify why Gaza's wounded are not being transferred to a third country. In a post on platform X, she said: "I suggest that the Supreme Court judges move their headquarters to Gaza and hold their sessions there. Shame!"
- Housing and Construction Minister Yitzhak Goldknopf attacked French
  President Emmanuel Macron, who stated in press remarks that "the United
  Nations decided to establish the state of Netanyahu." In a post on X, he said:
  "The land of Israel is the eternal home of the Jewish people since time
  immemorial, long before the establishment of the United Nations. This is how
  it was, and this is how it will always be."
- Minister in the Cabinet Gideon Sa'ar also attacked French President Macron, saying in a post on platform X: "Of course, Macron is wrong. Israel was not established by a decision from the United Nations. Israel was established through an international-Zionist decision, primarily during a difficult war and with the blood of the fighters of the liberation war from the small Hebrew settlement who overcame the invasion of the Arab states. If the partition borders in the UN resolution of 1947 were the borders of Israel, it is doubtful that Israel would have continued to exist to this day, even after its establishment."
- MK Yulia Malinovsky from the "Yisrael Beiteinu" party attacked U.S.
   Secretary of State Antony Blinken for a tweet he posted in which he called

on Netanyahu to stop the legislation concerning UNRWA and suspend its operations. She said in a post on X: "There is a lot of deep and important respect for the Americans, but interfering in Israel's legislative procedures is an overstep."

- MK Boaz Bismuth from the "Likud" party also incited against UNRWA, posting on X: "The bill I proposed to halt UNRWA's operations in Jerusalem has been placed on the Knesset table, and we will vote on it in its second and third readings at the end of this month."
- The Israeli Minister of Finance stated on Al Jazeera: "We must impose our sovereignty in the West Bank and Gaza after seeing how things end up in areas without Jewish sovereignty. The partition agreements for the land of Israel have never been and will never be useful, and the matter must also be resolved through settlement."
- So-called "National Security Minister" Itamar Ben-Gvir spoke at the conference titled "Jewish Settlement Alone Will Achieve Victory" on October 27, 2024, stating: "We can establish Kfar Darom, we can rebuild Netzer, Atzmona, we can return to our homes." He added that immigration should be encouraged, saying: "In truth, this is the most moral solution, and the best thing is not to impose it by force, but to say to them: 'We are offering you the opportunity, go from here to other countries."
- MK Tzvi Sukkot from Religious Zionism said at the conference: "The war
  must end with the seizure of land in the Gaza Strip, because settlement is
  essential for security." According to him, "This is the language the enemy
  understands, and Jewish settlement alone will lead to victory."
