#### Foreword:

The Israeli occupation is implementing a strategic agenda designed to displace Palestinians and establish a coercive, hostile environment. This agenda includes arming colonizers, granting them immunity from accountability, and providing extensive training to enable their attacks. In addition to the brutal actions carried out by the official apparatus of the occupying state, including relentless storming of cities and villages, executions, systematic destruction of infrastructure, and the deliberate starvation of innocent citizens, it persists in enforcing a harsh system of collective punishment on the Palestinian people, crossing numerous ethical and red lines. This ongoing tragedy is made possible by the international silence and its adopting of the shameful double standards. If it were not for this complicity, the Israeli occupation would be unable to perpetrate such horrific crimes under the watchful eyes of the global community.

These pre-planned strategies are being developed in collaboration between the occupying army and the colonizers, with the intention of attacking the citizens who are the rightful owners of the land, all in pursuit of controlling Palestinian territory. What has been particularly notable in recent times is the Israeli occupation state's tendency to establish colonial neighborhoods that are geographically distant from the main colony, aimed at controlling as much land as possible. This is a preparation for declaring these areas as separate colonies. This was evident in the recent announcement by the Israeli occupation government, which recognized the separation of 13 new colonial neighborhoods and classified them as legal colonies. Moreover, the Israeli occupying state has adopted a concerning approach regarding Palestinian construction. It has intensified demolitions at an unprecedented rate and has threatened to increase these actions across all areas. Additionally, citizens are being forced to bear the financial costs of these demolitions, as recently occurred in

Masafer Yatta. This measure is not merely oppressive; it is a deliberate attempt to deepen the suffering of Palestinian communities.



# First: Violations of the Israeli Occupation State & Colonizers in the Occupied Palestinian Territories in April 2025:

During the reporting period, April 2025, the Colonization & Wall Resistance Commission (CWRC) monitored 1693 attacks. These attacks were carried out by the

various bodies of the occupying state, including its colonial militia, against Palestinian citizens and their properties. Of these, 1352 attacks were carried out by the Israeli army, while 341 attacks were perpetrated by the



colonizers. These attacks included murder and physical injuries caused by live ammunition, tear gas, and terrorism, as well as storming cities and villages, vandalism, theft, confiscation of property, land bulldozing, and uprooting trees.

However, the majority of these attacks occurred in the governorate of Hebron which witnessed 292 attacks. This was followed by Ramallah Governorate (269 attacks). Meanwhile, 254 attacks were recorded in Nablus governorate. These governorates experienced intensive attacks, amounting to 48% of the total attacks. The other governorates faced a similarly difficult situation. The governorates of Bethlehem and Jerusalem experienced over one hundred attacks for each.

These attacks included 405 attacks on property and holy places, 87 attacks on lands and natural resources, and 1201 attacks on citizens.

A comparison of the total Israeli violations during the past three months:




### Attacks Perpetrated by Israeli Occupation State & Colonizers against Palestinian Citizens, their Properties and Holy Places.

#### **Attacks on citizens:**

During the reporting period, April 2025, the Colonization & Wall Resistance

(CWRC) Commission documented 1201 attacks on citizens. Most of these attacks were concentrated in Nablus Governorate which witnessed 198 followed attacks, by Ramallah Governorate which witnessed 180



attacks. Meanwhile, 179 attacks were recorded in Hebron governorate. These attacks included shooting, arrest campaigns, shutting down checkpoints and imposing traffic restrictions on citizens.



#### **Attacks on Lands & Natural Resources:**

In April 2025, the Colonization & Wall Resistance Commission (CWRC) has documented 87 attacks on the Palestinian lands and natural resources<sup>1</sup>. These attacks were concentrated in Hebron governorate which was subjected to 22 attacks, followed by Ramallah governorate which witnessed 21 attacks. Meanwhile, 13

attacks were recorded in Nablus governorate.

These attacks affected hundreds of dunums of citizens' lands. During the reporting period, April 2025, there were 10 attempts by



colonizers to establish colonial outposts in the governorates of Nablus, Tubas, Ramallah, Jericho, Salfit and Hebron. Additionally, the Israeli occupation authorities and colonizers carried out 33 bulldozing lands' operations. These operations were

concentrated in Ramallah Governorate, where 7 bulldozing lands' operations took place, followed by the governorates of Nablus and Hebron which were subjected to 6 bulldozing lands' operations for each. Meanwhile, 4 bulldozing lands' operations were recorded in Bethlehem.

#### **Attacks on Trees:**

During the reporting period, April 2025, the Colonization & Wall Resistance Commission (CWRC) documented 44 attacks that targeted olive trees and caused the uprooting, poisoning and burning of 1168 olive trees. These attacks were concentrated in the governorate of Hebron where 15 attacks were recorded, followed by the governorate of Ramallah which witnessed 11 attacks. Meanwhile, there were 7 attacks in Salfit governorate and 5 attacks in Nablus governorate.

#### **Attacks on Palestinians' Properties:**

In April 2025, the CWRC documented 405 Israeli attacks on Palestinian properties. During this period, the occupying army and colonial militias carried out extensive campaigns to confiscate and steal citizens' properties. The targeted properties included vehicles, home security cameras, agricultural tractors, solar cells, water tanks, livestock, money, and more.

Furthermore, there were 198 incidents of property vandalism and 59 documented incidents of confiscations and thefts of properties during the reporting period. Specifically, Israeli forces confiscated 9 vehicles,



1 surveillance camera recordings, 9 bulldozers and trucks, 2 water tankers, 2 towed vehicles, 8 solar energy systems, 12 water tanks, 14 fodder tables, and one case of stealing gold jewelry and cash. Additionally, there are reports of one case each involving the confiscation of health units, agricultural materials, fertilizers, photography equipment, and mobile phones. Meanwhile, the colonizers were involved in the theft of: 49 goats, 5 cases of stealing money, a vehicle and a donkey. Noteworthy, these confiscations and thefts were concentrated in tubas Governorate which witnessed 12 incidents, followed by Ramallah Governorate where 10 incidents of colonizers' confiscation were reported, and then Hebron Governorate, which recorded 8 cases of confiscation and theft of properties.




Colonizers' Attacks: According to what was monitored and documented by the Colonization and Wall Resistance Commission (CWRC) during the reporting period, April 2025, the colonizers carried out 341 organized attacks. These attacks varied between the occupation army's protection of the colonists in their storming of Palestinian cities and communities, breaking into Palestinian villages, confiscating citizens' property, drawing racist slogans on the walls, and bulldozing lands, as what happened in the villages of Beita, Qaryut, Iraq Burin, Al Rakiz area in Masafer Yatta, al Burj area in Dura, Khallet al Quton, Burqa, AL Asur mountain and other villages.

The most prominent of these colonial attacks was storming the holy places; among which was the squares of Al-Aqsa Mosque in the occupied city of Jerusalem. During the reporting period, April 2025, 4230 Israeli colonizers, protected by the occupation army, carried out 25 raids into Al-Aqsa Mosque Squares. Besides, 3215 colonizers carried out provocative tours under what is called "tourism to the squares of Al-Aqsa Mosque". Furthermore, the situation at the Ibrahimi Mosque in Hebron sharply deteriorated as occupation authorities implemented restrictions on prayer access.

This escalation peaked when Israeli Minister of National Security, Itamar Ben-Gvir, stormed the mosque under heavy security measures. During the "Jewish Passover holiday", the mosque was closed to Muslims worshippers and opened exclusively to colonizers for two days. The Israeli actions taken against al Ibrahimi Mosque represent a blatant and unprecedented attack, provoking the feelings of Muslims and showing a disregard for the sanctity of religious rituals.

Notably worth, most of these attacks were concentrated in Ramallah Governorate which was subjected to 65 attacks, followed by Hebron Governorate where 59 attacks were recorded. Meanwhile, 44 attacks were documented in Salfit Governorate.





#### **Examples on the Colonizers' Attacks carried out in April 2025:**



On April 1, 2025, more than 300 colonizers attacked the village of Duma, located south of Nablus, under the protection of the Israeli occupation army. The attack caused a significant damage and injuries among the residents. It included the partial burning of the cars belonging

to Ibrahim Dawabsheh and Ibrahim Abdel Razek Dawabsheh, the complete burning of Muhammad Abdel Razek Asaad's vehicle, and damage to parts of Muhammad

Yusuf's house. Additionally, three young men from the village, Ibrahim Fathi, Azhar Najeh, and the child Abdul Rahman Shalabi, were injured. Many others suffered from suffocation due to tear gas canisters. Furthermore, the village's electricity network was also targeted during the incident.





On April 4, 2025, a group of colonizers attacked a citizen and set fire to his vehicle in the village of Qira, located north of Salfit. They attacked the home of Mohammed Damen Abdo, assaulted him, burned his vehicle in front of his house, and drew racist slogans.

On April 7, 2025, a group of colonizers from the so-called "Karmel" colony, which is unlawfully occupying citizen land and property, stormed the village of Umm al-Khair, located in the Masafer Yatta area south of Hebron. They erected several caravans and a tent on land belonging to citizens with the intention of seizing the

property. Reports indicated that the colonizers conducted extensive excavation work on the surrounding land and planted trees, effectively encircling the village.

On April 7, 2025, A group of colonizers from the so-called "Karmel" colony and "Shimon" outpost, which were established on citizens' lands in Masafer Yatta, attacked the village of Umm al Khair, south of Hebron in the southern West Bank, and assaulted its residents while



they were at their home. Due to this brutal attack, four citizens, including an elderly woman and a child, were injured. The attackers used clubs and stones, and carried out the assault under the protection of Israeli occupation army. The injured included the young man "Alaa Shuaib al-Hathalin", the child "Rashid al-Hathalin", the elderly woman "Khadra al-Hathalin", and another woman. All four were transported to the hospital by Red Crescent teams for treatment, with their injuries described as moderate to minor.

On April 7, 2025, a colonizer ran over a 14-year-old child, Ahmed O'da, in the town of Huwwara on the main street. He was transported to the hospital, where his injuries were described as moderate to minor.



On April 8, 2025, a group of colonizers set fire to a wedding hall located between the towns of Sinerya and Bidya, west of Salfit. They also wrote racist and anti-Arab slogans on its walls. The "Flora Gardens" hall, owned by Mustafa Salama, was subjected to significant material damage due to the fire. Palestinian Civil Defense crews managed to control the blaze, preventing it

from spreading to neighboring areas. In addition to the fire, they found slogans such as "Death to Arabs" and "The people of Israel live" written on the hall's walls, reflecting the incitement tactics commonly used by colonizers' groups.



On April 9, 2025, a group of colonizers bulldozed 150 dunams of agricultural land in Khallet al-Qatn area, south of Bethlehem. This land belongs to "Suwais" family. On April 17, 2025, a group of colonizers began establishing a new colonial outpost in the town of Turmusa'ya, located northeast of Ramallah. They set up a tent on the eastern outskirts of town under the protection of the Israeli army and brought a herd of cattle to that area. This new outpost is situated near residents' homes and agricultural lands.

On April 18, 2025, a group of colonizers uprooted hundreds of olive trees and bulldozed approximately 2,000 dunams of Palestinian land in the village of Umm Safa, located northwest of Ramallah. They uprooted at least 500 perennial olive trees and paved a dirt road in the southern part of the village, connecting the colonies of "Halamish" to the west and "Ateret" to the east. In addition, on April 20, 2025, the colonizers began bulldozing additional areas of Palestinian land between the villages of Deir Sudan and Umm Safa to the north. Furthermore, in the area of "al-Ras" mountain, east of Umm Safa, they uprooted 300 olive and grape trees before advancing to the northern area to expand the colonial outpost they had established there.

On April 18, 2025, a group of colonizers attacked the citizen "Saeed Al-Amour" in Khirbet Al-Rakeez, located in Masafer Yatta, shooting him in the foot. As a result of the injury, his foot was amputated, and he is currently in detention. His 15-year-old son, Elias, was also arrested



during this incident. In addition, the colonizers installed water pipes and lines on Saeed's land under the protection of the Israeli occupying army, intending to seize his land.

On April 18, 2025, a young man from Silwad, located northeast of Ramallah, was injured after being attacked by colonizers near the entrance to the neighboring town of Deir Jarir. A group of colonizers assaulted several young men from Silwad with sticks and stones while they were working in agricultural fields adjacent to Deir Jarir. As a result of the attack, one young man sustained wounds and bruises, requiring him to be transferred to a hospital in Ramallah for treatment.



On April 19, 2025, a group of colonizers stole water pumps that were used to irrigate crops in the northern Jordan Valley. These pumps are essential for drawing water and delivering it to the fields of Palestinian farmers in Khirbet al-Deir, in the northern Jordan Valley. Additionally, there were attacks on solar panels in the area. Colonizers have been known to periodically steal water pumps and sabotage Palestinian water networks there.

On April 19, 2025, a group of colonizers burned agricultural crops in "Wadi al-Rakhim" community, located west of Susya village, south of Hebron. The colonizers, who were heavily armed and under the protection of Israeli occupying army, set fire to more than half a dunum of land that was planted with wheat and barley, owned by Ali Muhammad Shanaran. The blaze also destroyed equipment and wood intended for a house that was under construction.

On April 20, 2025, a group of colonizers attacked the properties of local citizens in the Wadi Qana area, located near the town of Deir Istiya, northwest of Salfit. They vandalized agricultural land owned by Jihad Mansour, Qasem Mansour, Abdul Razzaq Mansour, Nasser Mansour, and



Salah Mansour. The attacks involved the destruction of agricultural equipment and uprooting of several trees.



From April 21 to April 23, 2025, the "hill area" in the town of Sinjil, north of Ramallah, experienced several attacks by colonizers, who were protected by the Israeli occupation army. These attacks resulted in the martyrdom of the citizen "Wael Basem Ghafri" (48 years old) at the hands of the Israeli

occupation forces. Additionally, a young man from the town was injured by live bullets; one bullet penetrated his back and exited through his stomach. Seven other citizens suffered injuries from beatings and bruises. Furthermore, the colonizers set up a tent on the inner hill between Sinjil and Al-Mazraa Al-Sharqiya. During these attacks, citizens' farms were burned along with their belongings and official documents. Thirty heads of livestock were stolen, along with eight cans of oil. Additionally, hair houses were torched, vehicles were burned, trees were cut down, solar energy cells were destroyed, and numerous other acts of violence occurred.

On April 24, 2025, a group of colonizers attacked the village of Bardala, located in the northern Jordan Valley and set fire to tents and livestock pens. Reports indicate that the colonizers had previously attacked the northern side of the town and attempted to steal livestock. They also opened fire on residents, injuring five people. Meanwhile, the Israeli occupation forces obstructed the movement of ambulances, preventing them from reaching the injured. Additionally, nearby intersections experienced a heavy presence of colonizers, who were protected by the occupation army.

On April 26, 2025, a citizen named Abdul Fattah Ahmed Al-Tarwa, 55 years old, along with his wife, 50 years old, and his son, were injured in an attack by colonizers north of Hebron. The incident occurred when a group of colonizers stopped their

vehicle on Wadi Sa'ir Road and assaulted them with clubs and fists. The citizen sustained bruises and various wounds to his body. His wife suffered a broken arm, while their son, suffered head injuries. All three were taken to the hospital for treatment.

On April 27, 2025, a group of colonizers destroyed "Zanuta School", a challenge school, located east of Adh Dhahiriya, south of Hebron. They vandalized the school's renovations, which had been completed with the participation of the village council



and residents. The colonizers stole iron classroom doors, blackboards, and classroom partitions before ultimately destroying the school.

April 27, 2025: a group of colonizers, under the protection of the israeli occupation army, closed the entrance to Al-Auja community north of Jericho. They set up roadblocks at the entrance of the community, blocked citizens' vehicles, prevented them from passing, and isolated the community from its surroundings.

## Second: Procedures and Practices of the Occupation Authorities against Palestinian Facilities

**Demolitions:** According to the violations database of the CWRC, and during the

reporting period, April 2025, the Israeli occupation authorities carried out 73 demolitions that targeted 152 facilities in the West Bank, including Jerusalem.

Most of these demolitions were concentrated in Hebron Governorate, which witnessed



23 demolitions that resulted in the demolition of 39 facilities followed by Jerusalem Governorate, where 15 demolitions were monitored and resulted in the demolitions of 17 facilities. Meanwhile, 8 demolitions were recorded in Ramallah governorate and caused the demolition of 9 facilities.

The side graph shows that demolition operations are concentrated in the southern and central areas of West Bank. Because the relationship between demolitions and demolition notifications is inherent (see the notifications section), we notice the concentration (of both demolitions and notifications) in the south areas of West Bank. These notifications are concentrated in vast areas where the Israeli occupation seeks to evacuate and forcibly depopulate in favor of the settler-colonial project. During the reporting period, these demolitions included: inhabited residences, uninhabited residences, residences under construction, agricultural facilities, mobile homes (caravans), industrial and commercial barracks, and water wells.



#### B. Notifications (Demolition, Construction Moratorium, and Evacuation)

During the reporting period, April 2025, Israeli occupation authorities issued 46 notifications, including notifications of demolition, construction moratorium orders due to lack of permits, and eviction notifications under the pretext of



military training. The majority of these notifications were concentrated in Hebron Governorate, which received 16 notifications, followed by Ramallah Governorate, which had 14 notifications, and Jerusalem with 12 notifications.

The demolition notifications issued by the Israeli occupation authorities in the West Bank serve as one of the means they utilize to restrict Palestinians in Area "C" and obstruct their development and urban expansion. In light of the occupation's control of planning in these areas, they deny Palestinians their right to prepare master plans. Even when these master plans were submitted, they were rejected, preventing Palestinians from utilizing Area "C", which constitutes 61% of the West Bank. This area is being kept for the expansion of colonies and as a strategic reserve for future use.

#### Third: Land Expropriation (Land Confiscation)

In April, the occupation state seized a total of 54 dunums of citizens' lands through 4 seizure orders for military purposes. These orders aim to establish a buffer zone around the colony of Efrata, established on the lands of the Bethlehem Governorate, totaling 45 dunums, and another buffer zone around the colony of Nokdim, totaling 3 dunums. The order regarding the "Nokdim" colony targets the lands of the town of Silwad in the Ramallah Governorate, to construct a colonial road connecting the Tel al-Asour military camp to the main road between the towns of Silwad and Deir Jarir.

**First order:** The occupation forces seized a total of 45.12 dunums from the lands of Al-Khadir Village in Bethlehem Governorate under the pretext of land seizure for military and security purposes. This order carries the no. T\25\3 and aims to establish a buffer zone around the colony of Efrat established on the lands of Bethlehem Governorate.



**Second order:** The occupation forces seized a total of 2.906 dunums from the lands of Al-Khadir Village in Bethlehem Governorate under the pretext of land seizure for military and security purposes. An additional area previously declared as state land, totaling 16.99 dunums, was also allocated for the same purpose. This order carries the number T\25\1 and aims to establish a buffer zone around the colony of Nokdim.



**Third order:** The occupation forces seized a total of 1.452 dunums from the lands of Artas and the city of Bethlehem in the Bethlehem Governorate under the pretext of land seizure for military and security purposes. This order carries the number T\113\24 and aims to construct a colonial road connecting a colonial site to the main road.




**Fourth order:** The occupation forces seized a total of 4.344 dunums from the lands of Arab Silwad in the Ramallah Governorate under the pretext of land seizure for military and security purposes. This order carries the no. T\79\25 and aims to construct a colonial road connecting the Tel al-Asour military camp to the main road between the towns of Silwad and Deir Jarir.



Fourth: Colonial Expansion plans (Approved, Deposited)

#### First: Master Plans in the West Bank

In April, the planning authorities of the occupation state reviewed 21 master plans for the benefit of West Bank colonies, approving<sup>2</sup> 7 plans and depositing 14 others<sup>3</sup>. The plans targeted a total of 2927 dunums of private Palestinian citizens' land.



Analyses of the maps attached to the master plans indicate the occupation state's intention to expand the "Nokdim" colony, which is established on the lands of the villages of Arab At-Ta'amreh southeast of Herod's Palace in Bethlehem Governorate, through the approval of a master plan that aims to construct a new neighborhood for the colony (see the side map), to construct 290 new colonial units on an area of 239 dunums, under master plan number wy/ 12/ 411.

Not far off the aforementioned plan that aims to establish a colonial neighborhood linked to the Nokdim colony, a review of the maps attached to the master plan for the Ma'ale Amos colony reveals the occupation state's intention to construct a new colonial neighborhood affiliated with Ma'ale Amos. This plan, filed under No. יוש / 8/ 1/ 413 (see side map), proposes the construction of 148 new colonial units on approximately 42 dunums of land belonging to the village of Kisan, south of Bethlehem Governorate.



The occupation state has adopted a new policy of late. This policy aims for the establishment of colonial neighborhoods geographically distant from their parent colonies, with the aim of seizing as much land as possible in preparation for declaring these neighborhoods as separate colonies, as seen in the occupation government's recent announcement recognizing 13 such colonial neighborhoods as independent colonies.

Second: Master Plans and Bids for Colonial Units in Jerusalem The planning authorities of the occupation state, represented by the District Committee of the Jerusalem Municipality, reviewed a total of 6 master plans aimed at colonial expansion in the colonies established in Jerusalem. They approved 3 plans and deposited 3 others. These plans targeted the construction of 760 housing units, covering a total area of 103.298 dunums.

# Fifth: Laws and Bills proposed or approved by the Israeli Knesset during April 2025

In this part of the report, we review the most prominent of the laws and bills that were studied in the Occupation's Knesset. Considering the nature of these laws, their hostile and racist nature can be inferred, through which the legislative bodies in the occupation state seek to entrench a system of suppression against Palestinians or to perpetuate the racial segregation and apartheid imposed on them.

An example of this is the bills submitted by members of the far-right Knesset, which at times call for the full imposition of the occupation's sovereignty over the West Bank, and another bill that seeks to annul the Oslo Accords.

A glance at the set of laws currently under discussion reveals the mindset of the occupation and where it aims to go in terms of annexation, control over Palestinian land, and subjugation—openly and in plain sight of the world.

### Sixth: Attitudes and Racist Statements by Prominent Characters in the Israeli Occupation State

These days, leaders of the Israeli occupation have started making their racist statements unabashedly, revealing their superiority complexes and racist stances. In this section of the report, we will quickly review the most prominent statements.

- April 1<sup>st</sup>, 2025: Israeli extremist so-called "Minister of Finance", Bizalel Smotrich, posted on the X platform stating, "We have monitored closely the painstaking fight against Arab illegal construction and in favor of the development of colonies. The Israeli government is working on developing colonies in Yehuda and Samaria, and will not allow Arabs to continue with their illegal construction, which has become a setback for the country in the past decades"<sup>4</sup>.
- April 1<sup>st</sup>, 2025: The Israeli so-called "Minister of Foreign Affairs" Eli Cohen posted on "X" during his conversation with Congresswoman Claudia Tenney via the X platform: "There is a rule: the term 'West Bank' should not be used, only 'Judea and Samaria.""<sup>5</sup>
- April 9, 2025: Israeli Likud MK Dan Illuoz made a statement on the X platform, criticizing the international community for refusing to open its borders to Gazans for "migration." He said, "In front of hundreds of members

of parliament, I proposed a simple resolution: Those who have taken in refugees from Syria and Ukraine should also open up to Gazans."

- April 15, 2025: Knesset member Limor Ben-Son posted on the X platform: "We came to this gathering demanding the return of the people of Israel to their inheritance—the inheritance of their ancestors. There are no other options. Regardless of the circumstances, from the place where the killing came, there must rise a large and expansive settlement. And there, only the people of Israel will be—only sons and daughters playing in its (Gaza's) streets."
- April 14, 2025: Likud MK Osher Shkalim posted on platform X: "Today I visited the Nahal Movement camp in the Gaza Strip. It is a great honor to support the wonderful pioneers of Jewish settlement in the Gaza Strip. My commitment, and the commitment of many in Likud, is clear: settlement = security, settlement = victory. We will continue working together for a broad and strong Jewish settlement throughout the Land of Israel.".8
- April 10, 2025: Avigdor Liberman posted on X: "While 59 hostages are going through hell in captivity, the October 7 government is preparing the

- April 16, 2025: Tzvi Succot posted on X: "There is no reason in the world that we would send a gram of aid into Gaza while our hostages are languishing in captivity." <sup>10</sup>
- April 21, 2025: The so-called "Minister of Finance", Bezalel Smotrich, posted on X: "The 2025 revolution in settlement is the largest revolution made since 1967. We invest in settlement in infrastructure, tourism, and the connection of Israeli citizens to the Land of Israel."<sup>11</sup>
- April 21, 2025: The so-called "Minister of Finance", Bezalel Smotrich, posted on X: Mr. Prime Minister, your statement tonight that this war must end in victory has significance, and it is to change the method of war, to go for a full occupation of the Gaza Strip and not be afraid of a military government if necessary."<sup>12</sup>
- April 20, 2025: Israeli so-called "National Security Minister" Ben Gvir wrote on Facebook: "We will also get to the law for executing terrorists and the

electric chair." - Ben Gvir's statement at the opening ceremony of the Institute for Israeli Studies.<sup>13</sup>

- April 21, 2025: Ministers Idit Silman and Amichai Eliyahu stated during a visit to the northern West Bank via Facebook: "Our role is to impose sovereignty."<sup>14</sup>
- April 29, 2025: Quoting Yossi Dagan on Facebook: "The beginning of sovereignty is historical justice — and it is the guarantee of Israel's existence."<sup>15</sup>
- April 28, 2025: The so-called "Minister of Finance", Bezalel Smotrich, posted on platform X: "The establishment of dozens of new cellular sites throughout Judea and Samaria is another link in the chain of strengthening settlement and deepening sovereignty in the region." <sup>16</sup>
- April 23, 2025: MK Limor Son Har-Melech posted on platform X:"To win, there must be no Gazans, and none should remain there. Migration is the only solution." <sup>17</sup>

• April 24, 2025: Quoting the so-called "Nachala Settlement Movement" during the celebration of the 77th Independence Day of the Israeli entity in the settlement tent in Gaza on platform X: "Together, we raise the flag of settlement." 18
